TABLE of CEMETERY CHARGES

Charges were approved by Salcombe Town Council at its meeting on 11th November 2015

There are three categories of charges:

- **Category 'A'**: Current living residents of the Civil Parish of Salcombe. This includes those who move away due to age or infirmity such as to live in a nursing home or with family. This also includes those who were resident within the last five years.
- **Category 'B'**: Children of the current living residents of the Civil Parish of Salcombe.
- **Category 'C'**: Non-residents or second home owners residing less than 183 days of the year within Salcombe.

| Interment Fee for Burials, Cremated Remains (Casket & Ashes Only) | £95 | £95 | £285 |
| Cemetery Manager in Attendance at Ashes Interment (No Funeral Director Present) | £50 | £50 | £50 |
| Installation of Headstone (not exceeding 3' high x 2' wide) | £150 | £150 | £450 |
| Installation of Monument (not higher than 15") or Tablet | £100 | £100 | £300 |
| Additional Inscription to Existing Memorial | £80 | £80 | £240 |
| Family Trace (Per Named Entry) – Free Lookup - Fee for Info in Hard Copy or Digital Copy | £30 | £30 | £30 |

Note 1: Treble Burial Plot – These will only be allowable on condition that the gravedigger provides a method statement for the preparation of a grave to a suitable death. The gravedigger must also have and provide proof of suitable insurance cover for this type of work (Cat 'A' & Cat 'B' £1050 – Cat 'C' £3150)

Note 2: Deeds of Exclusive Right of Burial purchased after January 1st 2010 have a term of 30 years

Note 3: Buy back of unused pre-purchased plots is allowable by Salcombe Town Council and will be reimbursed on the basis of the original price paid less a 10% administration fee (Agreed by Council 28/10/2015)
