0459/18/TPO T1: Cupressus Macrocarpa - remove snapped, storm damaged hanging branch at 8m on NW side over neighbouring property Miramar above garden/pathway, remove snapped, storm damaged hanging branch at 9m on W side over neighbouring property above garden area, remove snapped branch on SW side at 6m hanging into branch below, remove long lowest branch on the SW side at 2.5m from ground level protruding over parking area and BT line at 7m from parking bay, ivy to be severed at base, frequently used parking area, busy two way carriageway Sunny Crag, Main Road, Salcombe, TQ8 8JW
